

A-Frame Signs Licence Application

Made under Section 68 Local Government Act and Section 138 Roads Act 1993 (NSW)

Muswellbrook Shire Council is the Road Authority for public roads within Muswellbrook Shire, with the exception of freeways and crown roads. To undertake work/activity on or alongside public roads, an A-Frame Signs Licence Application must be completed and a permit must first be obtained. This advises Council of the planned work/activity and allows Council to assess the necessary implementation of standards relevant to the work/activity being proposed. These specific standards need to be identified and adhered to, ensuring Muswellbrook Shire roads are kept safe and well maintained.

Council regulations for A-Frame signs

- A-Frame signs should only be erected in industrial and business zones. A-Frame signs may also be approved where bona fide existing uses are situated in other zones.
- A-Frame signs can only be erected on the part of the footpath that is adjacent to that business.
- A maximum of one (1) sign is permitted for each business.
- Dimensions of A-Frame signs shall not exceed a maximum display area of 0.5m².
- A-Frame signs should not be located within three (3) metres of similar signs or any street furniture.
- Applications for approval are to include the applicable annual payment to Council as outlined in the prescribed fees below.
- A certificate of currency of public liability insurance to the value of \$20 million must be provided with the application. The permit will only be valid whilst the insurance is current.
- A-Frame signs are to be secured to prevent danger to pedestrians and traffic in high wind situations.
- Compliance with the Roads Act 1993.
- Compliance at all times with Council's Local Environmental Plan 2009 on A-Frame signs.
