## S125 Application to use Footway for Restaurant Purposes

Made under Section 125 Roads Act 1993 (NSW)

Muswellbrook Shire Council is the Road Authority for public roads within Muswellbrook Shire, with the exception of freeways and crown land roads. To use the footway for restaurant purposes, an S125 Approval must first be obtained. This advises Council of the proposed use of the footway and allows Council to assess the necessary implementation of conditions relevant to the proposal. These specific conditions need to be identified and adhered to, ensuring Muswellbrook Shire footways are kept safe and well maintained.
